# LOUTH & DISTRICT HOSPICE LIMITED

Our overall aim is to develop and provide specialist services for people with incurable diseases, particularly those at the end of their lives and with complex care needs.

We provide **Hospice Day Care** in Louth Hospital and a **Home Support Service (Palliative Care)** in partnership with Age Concern, Lindsey, which is a domestic cleaning and sitting service. These services are available to people living in Louth and surrounding areas and are free to people using them. We rely on some funding from the NHS, but mainly on generous donations from local people, to provide these services.

We are planning a 6 bed inpatient unit and we hope to provide satellite Hospice Day Care in other towns in our catchment area.

Patients attending Hospice Day Care are cared for by specially trained nurses and dedicated volunteers. Assessed by the Team Leader, a care plan is developed to meet their needs, which could be clinical interventions, counselling or complementary therapies such as Reflexology or Arts & Crafts therapy such as card making, creating collages, pot planting, or creative writing. Families and Carers are also offered support and information. We do need your help to continue to provide this much needed service.

Our Hospice Members are very important to us in our fundraising efforts and development of services. The membership fee is £10 per person annually. Members can attend and vote at general meetings, receive regular updates and have the opportunity to comment on our progress.
